CropLife Africa Middle East, a member of CropLife International, is a regional Federation Representing the Plant Science Industry and a network of National Associations in 30 countries in Africa and the Middle East. Our company members include Arysta LifeScience, BASF, Bayer CropScience, Cheminova, Dow AgroSciences, DuPont, FMC, Monsanto, Sipcam Oxon, Sumitomo and Syngenta. These companies are committed to sustainable agriculture through innovative research and technology in the areas of Crop Protection, non-agricultural pest control, seeds and plant biotechnology.



CropLife Africa Middle East represents the "Plant Science Industry" in the countries of Africa and Middle East. The "Plant Science Industry" includes manufacturers and distributors of Crop Protection Products (Pesticides), seeds and biotechnology products.

As of the year 2009 the association consisted of:

- 11 company members.
- 30 national associations.
- 1 professional organization engaged in the promotion of suitable biotechnology for the African continent.

CropLife Africa Middle East has been registered as an international non-profit organization in Brussels in November 2002. The association is legally fully independent but maintains a strong cooperation with the global CropLife network.

In order to achieve the highest impact at the country and sub-regional levels a decentralized hub structure has been established with offices in:




Intellectual Property Rights/Anti-Counterfeiting

- In the context of updating the organisation’s priorities, the Executive Committee of CropLife Africa Middle East held in Milan on 2nd and 3rd of March 2009, ranked IPR and Anti-Counterfeiting among the top priorities for the region.
- The 3 annual hub workshops provided professional presentations on promoting compliance to various components of intellectual property rights.
- In Egypt, an Anti-Counterfeiting awareness campaign was launched with the support of the global Anti-Counterfeiting Steering Committee. The campaign concluded 8 training sessions to different audiences including regulators, extension staff, customs officers and law enforcement organs.
- In Kenya and Uganda, the Focus on Anti-Counterfeiting concentrated on:
 - Forming partnerships with NGOs, dealer organizations and other stakeholders to flight this scourge.
 - The creation of the “Anti-Counterfeiting Goods Bill” in Uganda is currently before parliament.
 - Raids by the authorities on suspect warehouses and goods impounded.
- In Yemen, CropLife Yemen coordinated a CropLife International mission for provision of technical advice on inspection and management of seized counterfeited stocks to the Ministry of Agriculture of Yemen in response to a request made by the government of Yemen.



Responsible Use/Integrated Pest Management

- Following the validation of the global IPM training course by the global secretariat, CropLife Africa Middle East managed to create a pool of regional master trainers by organizing a number of regional launches in Addis Ababa, Accra, Bamako and Amman, certifying master trainers for Anglophone, Francophone and Arabophone subregions.
- The year 2009 witnessed a greater emphasis on delivering the IPM course at country level in the entire region.
- ToT courses continued in the 3 subregional hubs together with farmer and agro-dealer training undertaken by certified master trainers.
- An association specialist has been appointed to provide for strengthening of national associations of the region with emphasis on stewardship key priorities.
- In this context, the association specialist has concluded a coordinated exercise whereby key performance indicators (KPIs) have been outlined for stewardship activities carried out by national associations. The KPIs report was based on 2008 activities and is being updated into 2009 and 2010.
- Technical and managerial support provided to distributor associations in Burkina Faso and Togo.
- A great deal of technical and financial support was provided to the region by the global Stewardship Steering Committee and the Global IPM Project Team.



Container Management

- In view of CropLife Africa Middle East commitment to safe and responsible management of empty Cleaned pesticide containers, a number of projects have been initiated. The status of these projects in countries of the region as at the end of 2009 is as summarized hereunder:

- **South Africa** : Approximately 70% of all containers are now collected and recycled.
- **Namibia** : Containers are being collected at government stores and recycled.
- **Kenya** : 10% of containers in the country are collected. An obstocks safeguarding project underway as a step towards national container management programme.
- **Uganda** : Collection programme to start mid 2010 as a multi-stakeholder project.
- **Ethiopia** : Collection scheme within flower industry to start 2010.
- **Madagascar** : Collection program commenced. 8200 drums disposed of and 5000 underway.
- **Mauritius** : Collection and recycling commenced 4th quarter 2009.
- **Malawi** : Collection and disposal of containers to commerce mid 2010.

- In WCA, limited container management is being undertaken by companies in line with tender requirements.

- In NAME, New projects are being initiated in Morocco, Egypt, Tunisia and Syria pending potential funding.

- In several other countries the survey process will start in 2010.



Obsolete Stocks

- The implementation of country projects within the Africa Stockpiles Programme (ASP) has been progressing at different speeds. The status of projects at the end of 2009 is elaborated hereunder:

- **Tunisia** : Inventory completed, CESA nearing completion and disposal planned for 1250 tonnes.
- **RSA** : Disposal of 100 tonnes financed by CropLife International.
- **Mali** : Inventory finalized for 1000 tonnes, CESA completed and disposal tendering started.
- **Morocco** : Inventory completed for 400 tons, project undergoing World Bank review.
- **Tanzania** : Inventory nearing completion.
- **Nigeria** : Inventory underway with new Technical Advisor recruited.
- **Ethiopia** : 2000 tonnes disposed of since the year 2000. CLI sponsored disposal of 350 tonnes is planned.
- **Mozambique**: 300 tones disposed. CLI sponsored disposal of 50 tonnes is planned.
- **Eritrea** : Inventory completed, safeguarding started 2009.

- CropLife International Safeguarding projects initiated in Kenya, Malawi, Ghana and Cameroun.





International Code of Conduct

- In the year 2009, a special emphasis was maintained on the rollout of the International Code of Conduct on the Distribution and Use of Pesticides.
- The three annual hub workshops dedicated practical working sessions where the CoC e-learning tool was demonstrated and rolled out to national associations and regulators.
- The International Code of Conduct, the Industry Guide on the Code together with the e-learning tool have been availed in English French and Arabic languages and distributed to national associations, regulators and local formulators regionwide.
- Country workshops for demonstration and rollout of the e-learning tool have been organised by national associations in a number of countries in the 3 regional hubs.
- An average of 100 CDs of e-learning tool were distributed in each of the 3 hub workshops.
- In WCA, training and demonstration sessions were conducted for 130 stakeholders and more than 200 CDs distributed .
- In ESA, training and demonstration session was held in Namibia for over 60 stakeholders with 100 CDs distributed.
- In NAME, demonstration sessions were organized in Egypt, Yemen, UAE and Jordan with more than 500 CDs distributed.



Regulatory Harmonization Initiatives



- CropLife Africa Middle East continued its Commitment to support the ongoing regulatory harmonization initiatives in the region. Three annual regulatory workshops were held in 2009 in linkage with the annual hub workshops in Douala (Cameroun), Windhoek (Namibia) and Dubai (UAE) in April, June and October respectively.
- The salient developments in the regulatory arena in the 3 regional hubs are:
 - The CropLife/AOAD co-driven initiative for NAME confirmed adoption of the approved harmonized documents for registration of pesticides in 15 member countries.
 - The CropLife SEARCH harmonized application form has been approved by SADC as the baseline document for registration of pesticides in SADC countries and is named the SADC Application Form for the Registration of Plant Protection Products. The networking of the form and acceptance by member states is likely to be a lengthy process.
 - The ECOWAS harmonization for West Africa made an important progress by the launch of the MIR PLUS project to pursue the activities in the ongoing regulatory harmonization process initiated by the former MIR, with the support of the Dutch DGIS. An advisory Committee of MIR PLUS has been set-up to guide and assist the project with CropLife elected as a member of the Committee.
 - Discussions on the evolution of the framework of the CEMAC Common Regulation for Central Africa outlined the need to link the framework to the regulatory system in Cameroun to capitalize on its experience to develop a workable framework for Central Africa.
- In March 2009, CropLife Africa Middle East constituted its Regional Regulatory Committee (RRC) composed of senior regulators from CropLife member companies. The RRC has provided an added value in Support of the regulatory initiatives in the region.

Biotechnology

- The year 2009 witnessed important strides in the adoption of biotechnology in the African continent.
- Four CropLife International funded organizations have been vigorously addressing the promotion of biotech applications in the entire region, these being AfricaBio, AFRICA HARVEST, ABSF and ISAAA, maintaining focus on different countries in Africa.
- The debate on biotechnology has shifted from the issue of safety to what crops and traits will add value for African countries. CropLife International Africa Partner Strategy is responding to increased demands to foster enabling environment for plant biotechnology.
- The focus countries addressing biotech promotion are divided into four tiers with the overall goal of moving towards commercialization and plantings:
 - Countries with current commercial plantings are South Africa, Egypt and Burkina Faso where focus is maintained on defending the technology, reducing complexity of regulations and communicating benefits of the technology.
 - Countries to go biotech commercial by 2012 are Kenya, Uganda and Malawi where main focus is to support commercialization of crops (cotton, Banana, maize), ensure passage of required legislations and provide stewardship and regulatory training.
 - Countries to launch biotech trials by 2010 are Mali, Tanzania and Mozambique with focus on support of field trials and raising biotech awareness and knowledge.
 - Monitor countries for 2012 include Benin, Cameroun, Zambia, Senegal, Rwanda, Swaziland, Tunisia, DRC and Angola. The key focus being on developing biosafety systems and encouraging political support for the technology.



Communication

- CropLife Africa Middle East, with the assistance rendered by the global Communication Steering Committee (CSC), developed a regional communication plan for the years 2009 and 2010.
- The objective of the plan is to implement cost-effective, fully leveraged and well-aligned strategies and actions to positively impact policy, regulations and reputation of the industry. The goal is to create the maximum freedom-to-operate for the industry.
- The regional plan outlined the different communication components including messaging requirements, Communication tools, identified audiences, media relations and monitoring. The plan recommended creation of a regional media plan (already in place) together with utilization of E-tools (website, knowledge hub, farmer profiles). Specific actions with timelines were incorporated in the plan as of September 2009 until December 2010.
- An important component of the plan was the organization of training workshops to raise communication skills of national associations. Three workshops were conducted by Anna Riley in linkage with the annual hub workshops in Douala, Windhoek and Dubai during 2009.
- Communication tools were rolled out to all national associations of the three regional hubs.
- The website and Newsletter continued to provide useful communication tools for the organisation. The website scoring an average of ca 2000 hits per month.
- Communication with other stakeholders included interviews, press releases, and reports by national and international media on regional activities.
- “Afrique Agriculture” continued to provide regular coverage of subregional workshops, while articles and reports were published periodically by partners such as IFDC and ATP on common activities.



Rollout of Communication Tools to National Associations and Administrative Authorities

Alliances and Partnerships

- While maintaining ongoing regulatory and stewardship initiatives with COMESA, SADC, FANRPAN, CNFA, AOAD, FAO and ICARDA in both ESA and NAME subregions, two important alliances have been developed in WCA during 2009:

■ **International Centre For Soil Fertility And Agricultural Development (IFDC):**

- Capitalizing on the success gained in the first 5-year phase of cooperation between CropLife Africa Middle East and IFDC, the two organizations decided to extend their Cooperation for another 5-year term by drafting and signing a renewed Memorandum of Understanding.

- The signing ceremony took place on 3rd June, 2009 in Accra, Ghana. Signatories were Dr. Rudolf Guyer, Executive President of CropLife Africa Middle East and Marjatta Elitta, Director of IFDC North West Africa.

■ **Agribusiness and Trade Promotion:**

- Cooperation with the USAID funded project ATP aims at improving agricultural productivity to strengthen the intra-regional market on agricultural produces in the ECOWAS region. Joint activities target stewardship with emphasis on promoting IPM/RU and build capacity on other aspects such as business linkage of quality products to farmers and producers, create awareness and promote advocacy for the avoidance of illegal inputs. The cooperation will support farming towards a market-oriented approach to transform subsistence agriculture into small scale enterprises, thus improving the livelihoods of rural population in the subregion.



CropLife Africa Middle East allies with IFDC and USAID-ATP

Financial Performance

- The prime concern for the Executive Board of CropLife Africa Middle East through the year was directed to sound governance of financial resources and monitoring of administrative and operational spending, while preserving the existing subregional structures. The objective was to maintain the notable expansion in regional activities in light of the limited available funding.
- With substantial funding rendered by CropLife International and the financial contributions levied from member companies and associations, the organization was able to implement the approved action plans for 2009, however with eight percent shortfall in the overall regional spending, dictated by considerable losses due exchange rate differences and the engagement in necessary consultancies.
- A major effort needs to be exerted towards increasing the association's funding to sustain existing levels of activities and stakeholder exposure.
- The executive board has attached paramount importance to developing a quality scheme project aiming at increasing the revenues beyond the current levels. The implementation of the quality scheme is likely to be a lengthy process before it is adequately operational.
- The organization therefore aspires for continued financial support from CropLife International in the short and medium terms.




